# Enrollment Policies

**ADMISSION REQUIREMENTS:** To be considered for admission to The Andressa Academy High School, students must meet the following requirements:

- Submit a completed application form
- Provide transcript(s) from previous schools attended if seeking to apply for credits
- Demonstrate proficiency in English language skills via a proficiency exam

**OPEN ENROLLMENT:** We offer open enrollment, meaning students can enroll anytime.

**CREDIT TRANSFER POLICY:** We accept credits earned from other accredited high schools. Students must submit an official transcript from their previous school and the course syllabus to transfer credits. Our team will review the transcript and syllabus to determine if the credits are transferable.

**AGE REQUIREMENT:** Students must be at least 13 years old to enroll in The Andressa Academy High School and/or have completed a minimum of 8th grade. There is no upper age limit.

**ENGLISH PROFICIENCY REQUIREMENT:** To be eligible for admission, students must demonstrate proficiency in English language skills. This will be demonstrated by taking an English proficiency exam.

**STATEMENT OF FAITH SIGNATURE:** Students and parents must provide a written statement acknowledging the school's Christian beliefs and values. Students are not required to be Christians to enroll.

**PARENT GUARDIAN SIGNATURE:** Students under 18 must have a parent or guardian provide a signature authorizing their enrollment.

**ACCEPTANCE NOTIFICATIONS:** All students that meet the minimum entrance requirements will be accepted into the program. Once the enrollment process has been completed, students will be given the link to begin their courses.

# Attendance Policies

- Attendance is an important aspect of online learning, and as an online Christian high school, we value regular attendance as a way for students to demonstrate commitment and accountability in their education. Therefore, we have implemented the following attendance policies:
- Students must log in to a course at least once per week to be considered in attendance for that week. This includes actively participating in course discussions, completing assignments, and communicating with teachers and classmates as needed.
- Students must complete at least three courses per year to maintain their enrollment status. If students fail to complete this minimum requirement, they will be unenrolled from the school.
- In extended absences due to illness or other personal circumstances, students should communicate with the office as soon as possible to make arrangements for putting their coursework on hold.
- Excused absences may be granted for extenuating circumstances, such as illness, family emergencies, or other unforeseen events. To request an excused absence, students should communicate with their teachers and provide documentation or a detailed explanation of the circumstances.
- Unexcused absences may result in a deduction of points or grades, and repeated unexcused absences may lead to disciplinary action or enrollment review.
- The school regularly monitors attendance and communicates with students and parents to address concerns or issues.

# Grading Policies

## GRADING POLICIES

**GRADING SCALE:** The grading scale used by the school is defined as follows, including what percentage range constitutes each grade (e.g. A = 90-100%, B = 80-89%, C = 70-79%). Any grade below 70 is not considered a passing grade, and students must pay a \$10 fee to retake the course.

**WEIGHTED GRADES:** Each course consists of 30 lessons, and students can earn up to 500 points in each course.

- **Daily Quizzes (300 points):** Each Daily Reading Quiz and Daily Lecture Quiz question is worth 1 point a piece.
- **Weekly Exams (120 points):** Each of the 20 questions on the six weekly exams is worth one point a piece for 20 points per exam.
- **Final Exam (80 points):** The final exam consists of 10 questions worth 8 points each.

**LATE WORK POLICY:** Students have a maximum of 90 days to complete a course. After 90 days, a student will not

**EXTRA CREDIT POLICY:** No extra credit is allowed for any course.

**GRADE DISPUTES:** Students who wish to dispute a grade must contact the office within five days of their grade being posted.

**GRADING TRANSPARENCY:** Students and parents may login to the student portal to download an unofficial transcript copy or to see the progress of their grades.

**Academic Integrity:** Academic dishonesty, which includes plagiarism, cheating, and other forms of misconduct, violates the values and principles of The Andressa Academy community. Such behavior undermines the integrity of the educational process and is detrimental to our student's intellectual and moral development.

The Andressa Academy High School expects all students to maintain the highest standards of academic integrity. This means that students must:

- Complete all assignments and assessments in accordance with the instructions provided by teachers.

## GRADING POLICIES, CONT.

- Avoid plagiarism, which includes using the work of others without proper citation or attribution.
- Avoid any form of cheating, which includes sharing answers, copying from other students, or using unauthorized materials during assessments.
- Refrain from submitting the same work for different assignments or courses without prior approval from the teacher.
- Refrain from tampering with any part of the online course or assessment, including the online platform or software.

Students who violate this academic integrity policy may be subject to disciplinary action, including but not limited to a lowered grade, a failing grade for the assignment or assessment, suspension, or expulsion from the school. # Student Conduct Policies

## STUDENT CONDUCT POLICIES

**DISRUPTIVE BEHAVIOR:** Disruptive behavior, including behavior that interferes with the learning or safety of others, will not be tolerated. This includes behavior such as excessive noise, use of inappropriate language, or refusal to follow instructions from teachers or administrators.

## STUDENT CONDUCT POLICIES, CONT.

**REPORTING:** Any student who witnesses or experiences behavior that violates these student conduct policies should report it immediately to a teacher, administrator, or other school staff member.

# Technology Policies

The Andressa Academy High School is committed to providing a high-quality education that is accessible to all students, regardless of their geographic location or socio-economic background. To ensure that our technology is used effectively and responsibly, we have established the following policies:

**ACCEPTABLE USE POLICY:** All students are expected to use school technology resources responsibly and per school policies. This includes but is not limited to:

- Accessing school technology resources only for academic purposes
- Respecting the privacy of other users and refraining from attempting to access, modify or destroy other users' files, data, or passwords
- Refraining from accessing inappropriate websites or engaging in inappropriate online behavior
- Complying with all applicable laws and regulations, including copyright laws

**DATA PRIVACY POLICY:** The Andressa Academy collects and stores student data, including personal information, academic records, and assessment data. We are committed to protecting the privacy and security of student data and have established policies to ensure that all data is collected, stored, and used per applicable laws and regulations.

**CYBERBULLYING POLICY:** The Andressa Academy has a zero-tolerance policy for cyberbullying, defined as any behavior intended to harm, intimidate or harass another person using technology. We take all reports of cyberbullying seriously and will take appropriate action to address such behavior.

**DEVICE POLICY:** Students are responsible for providing their own devices for online learning, whether a computer or cell phone. The school is not responsible for any damage or loss of the device. Students are also expected to maintain their devices and keep them up to date with the latest software and security updates.

**COMMUNICATION POLICY:** All communication between students and teachers must be conducted through school-sanctioned communication platforms, such as email or online discussion boards.
